Pursuant to regulation 30 of SEBI (Listing Obligations and Disclosure Requirements). Regulation 2015, we would like to inform you that our company Godawari Power & Ispat Limited (GPIL) has exercised conversion option for converting 31,00,000 Optionally Convertible Cumulative Preference Shares (OCCPS) of its subsidiary company Godawari Green Energy Limited (GGEL) of Rs.100/- each into equal number of equity shares of Rs.10/- each at a premium of Rs.90/- per share. Similarly M/s. Shiv-Vani Energy Limited (SVEL) another strategic investor of GGEL has also opted for conversion of 56,00,000 OCCPS of GGEL of Rs.100/- each into equal number of equity shares of Rs.10/- each at a premium of Rs.90/- per share.

Accordingly GGEL has allotted 31,00,000 equity shares of Rs.10/- each at a premium of Rs.90/- per share on 01.09.2016 to our Company (i.e. GPIL) upon conversion of 31,00,000 OCCPS of Rs.100/- each and has allotted 56,00,000 Equity Shares of Rs.10/- each at a premium of Rs.90/- per share to SVEL in its meeting held on 01.09.2016.
