Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 (as amended), and the Circulars issued by the Ministry of Corporate Affairs dated April 08, 2020, April 13, 2020, May 05, 2020 January 13, 2021 and May 05, 2022 the Company is providing facility of remote e-voting to its Members in respect of the business to be transacted at the EGM. For this purpose, the Company has entered into an agreement with National Securities Depository Limited (NSDL) for facilitating voting through electronic means, as the authorized agency. The facility of casting votes by a member using remote e-voting system as well as venue voting on the date of the EGM will be provided by NSDL.
2. The Notice of EGM is being sent, in electronic mode to those members whose, e-mail addresses are registered with the Company/ RTA or the Depository Participant(s) as on 09<sup>th</sup> December 2022. The Notice will be sent to all other members by post to their registered address. A person who has acquired the shares and has become a member of the Company after the dispatch of the Notice of the EGM and shareholders as on Cut-off date i.e. 14<sup>th</sup> January, 2023, shall be entitled to exercise his/her vote electronically i.e. remote e-voting or e-voting system on the date of the EGM by following the procedure mentioned in **Annexure-A**.
3. CS Brajesh R. Agrawal, Practicing Company Secretary (CP No. 5649 & Membership No. F5771) BR Agrawal & Associates has been appointed as the Scrutinizer to scrutinize the e-voting process and Poll during the EGM (if any) in a fair and transparent manner.
4. The Scrutinizer shall within a stipulated period from the conclusion of the e-voting period unblock the votes in the presence of at least two (2) witnesses not in the employment of the Company and make a Scrutinizer's Report of the votes cast in favour or against, if any, forthwith to the Chairman of the Company.
5. The Results shall be declared on or after the EGM of the Company. The results declared along with the Scrutinizers Report shall be placed on the Company's website and on the website of NSDL within two working days from the conclusion of EGM of the Company and communicated to the Stock Exchanges (i.e. NSE & BSE).

**EXPLANATORY STATEMENT IN RESPECT OF THE SPECIAL BUSINESS PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013**

M/s. JDS & Co., Statutory Auditors (FRC 018400C) was appointed as Statutory auditors for the second term of five years period to hold office from the conclusion of 23rd Annual General Meeting i.e. September 16, 2022 till conclusion of the 28th Annual General Meeting to be held in the year 2027.

Subsequently, M/s JDS & Co. has been merged with M/s Singhi & Co. Chartered Accountants having Firm Registration No. 302049E with effect from 15th November 2022. The Company has received aforesaid information on December 03, 2022 through a letter issued by M/s. Singhi & Co. Consequent upon aforesaid merger, the Board of Directors, upon recommendation of audit committee and subject to approval of shareholders has approved the appointment of Singhi & Co. as statutory auditor in its meeting held on 09<sup>th</sup> December 2022 and recommended for approval of the shareholders of the Company on the same terms and conditions including remuneration and tenure on which M/s JDS & Co. was appointed by the shareholders and Board of directors of the company.

Singhi & Co. has been in the profession for over 80 years and is one of the reputed audit firms in the country. They serve multiple listed companies and have tremendous experience in the field of Audit. Singhi & Co. has over 30 partners with 9 offices across the country.

The Audit Committee and the Board of Directors considered the following factors in recommending the appointment of Singhi & Co. as the Statutory Auditors,

Performance of Singhi & Co. as Statutory Auditors, Experience of the firm in handling audits of large corporates; Competence of the leadership and of the audit team of the firm in conducting the audit of the financial statements of the Company; Ability of the firm to seamlessly scale and understand the Company's operations, systems and processes; and Geographical presence and ability of the firm in servicing the Company and its subsidiaries/Associates etc. at multiple locations.

The company has paid Rs.35.00 Lakhs towards Audit Fees for the FY 2021-22. The Audit Committee and the Board is of the view that Rs.40 Lakhs (plus applicable taxes and reimbursement of out-of-pocket expenses) is reasonable audit fee considering the size and scale of the Company for FY 2022-23. The remuneration to be paid to Statutory Auditors for the remaining term i.e. from FY 2023-24 through FY 2026-27 (till the conclusion of the 28<sup>th</sup> AGM of the Company to be held in the year 2027), shall be mutually agreed between the Board of Directors and the Statutory Auditors, from time to time.

None of the Directors / Key Managerial Personnel of the Company and their relatives is, in any way, concerned or interested, financially or otherwise, in the resolution set out at item No. 1 of the Notice.

The Board recommends the resolution set forth in Item No. 1 for the approval of the Members by way of a special resolution.

## ANNEXURE-A

### THE INSTRUCTIONS FOR MEMBERS FOR REMOTE E-VOTING ARE AS UNDER:-

The remote e-voting period begins on Wednesday, 18<sup>th</sup> January, 2023 at 09:00 AM and ends on Friday, 20<sup>th</sup> January, 2023 at 05:00P.M. The remote e-voting module shall be disabled by NSDL for voting thereafter. The Members, whose names appear in the Register of Members / Beneficial Owners as on the record date (cut-off date) i.e. Saturday 14<sup>th</sup> January, 2023, may cast their vote electronically. The voting right of shareholders shall be in proportion to their share in the paid-up equity share capital of the Company as on the cut-off date, being 14<sup>th</sup> January, 2023.

#### How do I vote electronically using NSDL e-Voting system?

*The way to vote electronically on NSDL e-Voting system consists of “Two Steps” which are mentioned below:*





#### **Step 1: Access to NSDL e-Voting system**

##### **A) Login method for e-Voting for Individual shareholders holding securities in demat mode**

In terms of SEBI circular dated December 9, 2020 on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-Voting facility.

2. Select “EVEN” of company for which you wish to cast your vote during the remote e-Voting period.
3. Now you are ready for e-Voting as the Voting page opens.
4. Cast your vote by selecting appropriate options i.e. assent or dissent, verify/modify the number of shares for which you wish to cast your vote and click on “Submit” and also “Confirm” when prompted.
5. Upon confirmation, the message “Vote cast successfully” will be displayed.
6. You can also take the printout of the votes cast by you by clicking on the print option on the confirmation page.
7. Once you confirm your vote on the resolution, you will not be allowed to modify your vote.

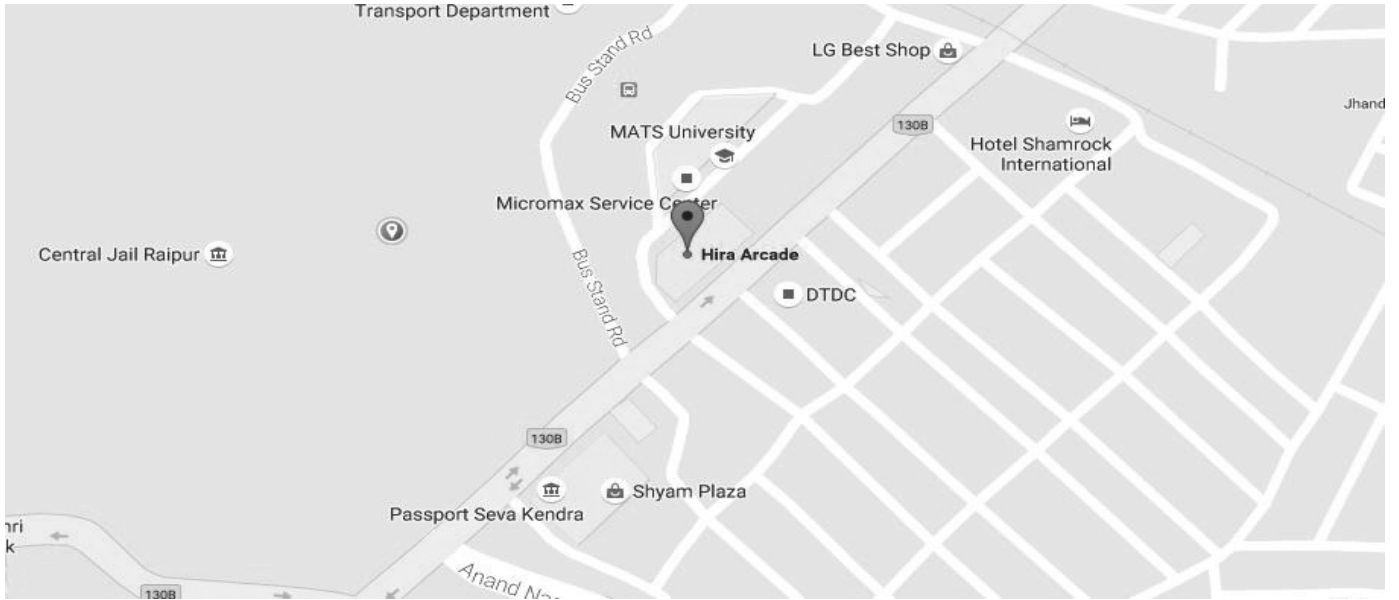
