Subject: Information regarding Commencement of Production of Structural Steel in

Rolling Mill and Synchronization of 20MW Solar Power Plant with Grid.

Pursuant to the Regulation 30 of SEBI (LODR) Regulations, are pleased to inform you that the modification of Rolling Mill of the Company at Urla Industrial Area, Urla, Raipur, Chhattisgarh for manufacture of Structural Steel has been completed for manufacture of Structural Steel and the started production of Structural of Steel. The Structural Steel will be partially used captively for manufacture of Galvanized Fabricated products for supply to Government agencies like Indian Railways, Power grid and state discoms etc., for which Company has applied to these agencies for approval their as approved vendors for supply of structural steel for manufacture of Fabricated & Galvanized products. The Company expects to get these approvals for within next 2-3 months. It may be mentioned that the Company's Fabrication & Galvanization Division is already an approved vendor for Indian Railway, Power Grid and state Discom etc. The raw material i.e. Steel Billets required for said rolling mill is being supplied from Integrated Steel Plant located at Siltara Raipur, Chhattisgarh.

The Company is also in the process of adding a separate line in the said rolling for manufacture of Strips, the construction work for which is in progress and expected to be completed within a few weeks. Upon commencement of production of Strips, the same will be captively used for manufacture of ERW Pipes. It may be mentioned that the Company has capacity of 600000 MTPA for the manufacture of ERW Pipes.
